1 Introduction

1.1 Scope

The purpose of the Release Note is to document the new functionality provided by the release and any known issues or limitations. The release notes will also record any administrative instructions that are specific to this release and not recorded elsewhere.

1.2 Purpose of Release

This is a full maintenance release that builds on previous release to support WebLogic 12.1.3 and adds some improvements to the PostgreSQL extension as detailed below.

1.3 System Requirements

1.3.1 Operating system

This version of 1Transact is supported on the following operating systems:

- Microsoft Windows Server 2012
- Oracle Linux 6.7

1.3.2 Hardware

Minimum hardware configuration:

- Minimum of 4Gb RAM
- Minimum of 2 CPU cores
- Hardware is dependent on required response times and throughput. Heavily used multi-user systems
 will need higher server specifications, please contact 1Spatial support (see below) for guidance on
 server configurations.

 Oracle WebLogic Server 12.1.3. Standard edition or Enterprise edition (Enterprise Edition only needed if clustering multiple WebLogic servers for resilience and scalability)

2 Release details

The following sections provide a description of this release of 1Transact.

Note: The PostgreSQL extension version number is not locked to the 1Transact version number. This version's PostgreSQL extension number is .

Note: Previously, the master version and initial checkpoint metadata were created when the extension was installed. In order to support seamless backup and restore these are now lazily created when a table is first activated. This means that the version, checkpoint and closure metadata tables in the sms_1transact schema will appear empty until the first table is activated, but after this the content and structure of these tables are unchanged from previous versions.

2.1 Upgrading the PostgreSQL extension from a previous release

You can then follow the 1SMS installation guide's chapter on installing 1Transact and follow the instructions for updating the Postgres extension, which will retain your current configuration, please note the following additional instructions:

Version 2.0.4 of the PostgreSQL extension will create an index on end_ckpts columns on newly activated tables, but not on tables that are already activated. If you have not already done so you can add the index to tables which have already activated by previous releases of 1Transact by using this SQL: Apply this to each activated table or, if the table is partitioned, then this command needs to be run using the name of each of the child partition tables.

CREATE INDEX ON <schema>.<activated table> vm (end ckpts);
```

Where the schema is the table's schema and activated_table is the name of the activated table (which now has been renamed with an _vm suffix)
