1Data Gateway's intuitive interface provides easy and secure access, enabling users to securely upload spatial and non-spatial data files and download the results generated. Utilizing the 1Integrate rules engine, 1Data Gateway performs complex validation, corrections and/or enhancements – delivering fast results to users with zero training. It can be used to provide a data validation or processing portal to external or internal end users and provides analytics and a dashboard of the quality of the submitted data over time.

**Notes:** 1Data Gateway's user interface is built using the MaterialUI framework that includes accessibility features built-in by default.

1Data Gateway provides additional context through a map viewer. The Map Viewer is not essential and all information that is being displayed through the map is also accessible through the extra elements an therefore that component is not assessed in this report.
