

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023 baseline and the measures will be in effect when performing the contract. The carbon emission reduction achieved by these schemes equate to 151.3 tCO2e, a 20.3% reduction against the 2023 baseline.
