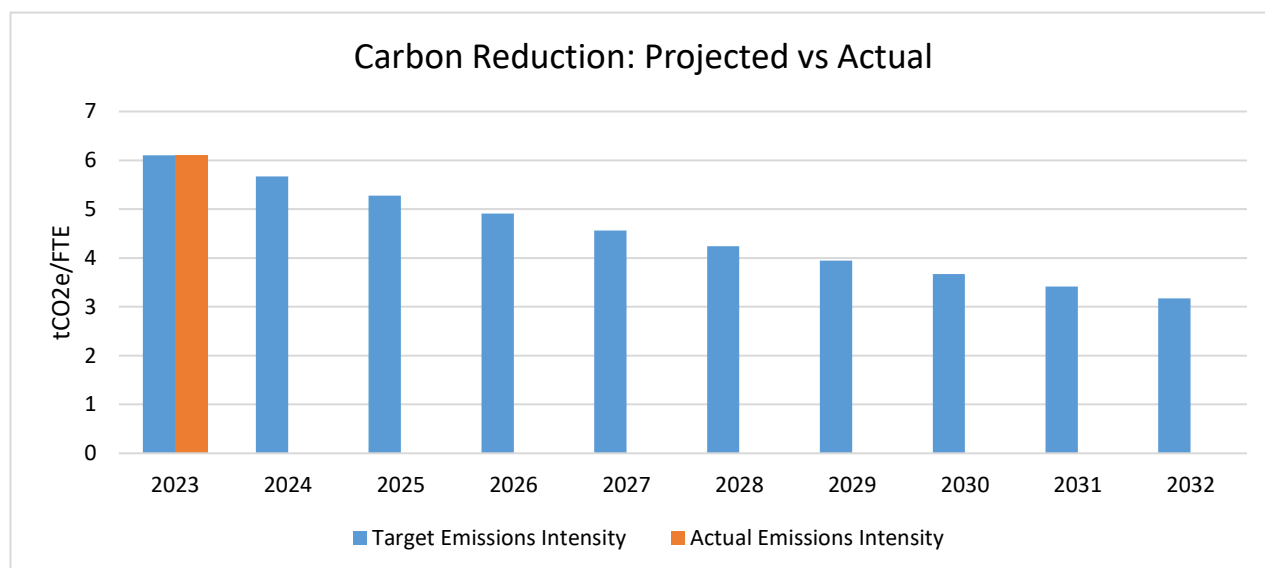

## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that the intensity of our carbon emissions will decrease over the next ten years from 6.1 tCO<sub>2</sub>e/FTE to 3 tCO<sub>2</sub>e/FTE by 2033. This is a reduction of 51.6 %

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the baseline and the measures will be in effect when performing the contract.

- Developed baseline targets and implemented measures to track carbon emissions.
- Sustainable travel scheme support globally, including subsidies available for using public transport or bikes.
- Electric vehicle charging installation, with future company vehicle procurement review
- We have recycling initiatives across our offices including recycling our computer equipment. We actively source and choose recycled stationary and other office supplies wherever possible.
- We have offset the emissions from our website

### Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Adopt a Sustainable travel policy and make it easier to book public transport
- Move to smaller, more fuel efficient premises
- Make renewable energy part of the discussion on new premises selection
- Create stakeholder engagement plans for; Critical suppliers; Employees and Company Leadership
