Case Study (Boone County, West Virginia)

The 1Spatial /Pro-West team supported Boone County in its NG911 preparation. The team began by gathering all data elements - road centerlines, address points, ESN zones, zip code boundaries, and much more - before loading data into the schema that matched the State of West Virginia's NG911 requirements. Any datasets that were in a different schema were mapped to the new schema.

Analysis and clean-up began, comparing data sets to make sure information was consistent, eliminating gaps and overlaps in geometry to ensure seamless emergency response cover, flagging and resolving errors and much more. Tools in the State's 1Spatial data portal were used to automate many of the necessary data checks, working through and checking off each validation phase task by task. The team used the scoring provided by the portal to track and visualize progress. Throughout the clean-up process, the 1Spatial/Pro-West team and Boone County collaborate to make decisions on errors and inconsistencies and identify valid exceptions.

Eventually, Boone County's data was ready for submission to the State via the portal.

But NG911 data preparation doesn't end there. The county must have a plan for maintenance if it is to remain at the standard required. Boone County's 911 data will follow a collaborative plan, where the County and 1Spatial/Pro-West will each be responsible for maintaining dedicated datasets to ensure authoritative information for fast and accurate emergency response.
